this book proposes a new pragmatic way of approaching economic development which features policy learning based on a comparison of international best policy practices while the important role of government in promoting private sector development is being recognized policy discussion often remains general without details as to what exactly to do and how to avoid common pitfalls this book fills the gap by showing concrete policy contents procedures and organizations adopted in high performing east asian economies natural resources and foreign aid and investment can take a country to a certain income level but growth stalls when given advantages are exhausted economies will be caught in middle income traps if growth impetus is not internally generated meanwhile countries that have soared to high income introduced mindset policies and institutions that encouraged or even forced accumulation of human capital skills technology and knowledge how this can be done systematically is the main topic of policy learning however government should not randomly adopt what singapore or taiwan did in the past a continued march to prosperity is possible only when policy makers acquire capability to formulate policy suitable for local context after studying a number of international experiences developing countries wanting to adopt effective industrial strategies but not knowing where to start will benefit greatly by the ideas and hands on examples presented by the author students of development economics will find a new methodological perspective which can supplement the ongoing industrial policy debate the book also gives an excellent account of national pride and pragmatism exhibited by officials in east asia who produced remarkable economic growth as well as serious effort by an african country to emulate this miracle the open access version of this book available at taylorfrancis.com/doi/view/10.4324/9780203085530 has been made available under a creative commons attribution non commercial no derivatives 4.0 license

this volume is based on an extended research program conducted by the institute of developing economies in tokyo which offered insights into models of economic growth

the debate on the major factors contributing to southeast asian industrialization continues unabated as might be expected there is much at stake in

this debate the debate is largely ideological in nature and partly centers on the role and contribution of state interventions and other institutions in market processes in the context of late industrialization at the risk of caricaturing the debate on the one hand one finds the dominant and more influential position held by those who blame the state for all that has gone wrong and credit the market for all that has turned out right on the other hand the minority statist extreme position basically credits most major economic achievements in east asia to appropriate interventions by developmentalist states while very few people would actually fully identify with either of these caricatured extremes much of the discussion actually gravitates around either of these poles

malaysian industrial policy argues that selective government promotion efforts have been successful and crucial for malaysias industrialisation despite some disastrous consequences associated with the mahathir governments heavy industrialisation programme the authors present evidence to show that direct and indirect government interventions have induced and supported investments accelerating the structural transformation of the malaysian economy however industrial development in malaysia has been modest compared with that in northeast asia because of weaknesses in industrial policy and excessive reliance on foreign investments

the prevailing view of industrialization has focussed on technology capital entrepreneurship and the institutions that enabled them to be deployed labour was often equated with other factors of production and assigned a relatively passive role yet it was labour absorption and the improvement of the quality of labour over the course of several centuries that underscored the timing pace and quality of global industrialization while science and technology developed in the west and whereas the use of fossil fuels especially coal and oil were vital to this process the more recent history has been underpinned by the development of comparatively resource and energy saving technology without which the diffusion of industrialization would not have been possible the labour intensive resource saving path which emerged in east asia under the influence of western technology and institutions and is diffusing across the world suggests the most realistic route humans could take for a further diffusion of industrialization which might respond to the rising expectations of living standards without catastrophic environmental degradation

examines how african policy makers might develop better coordination between the public and private sectors to identify the constraints to faster structural transformation and to design implement and monitor policies to remove them

economy as a periphery could make a transition to the emerging state capable of undertaking the task of economic development and industrialization it offers historical and contemporary case studies of transition as well as the international background under which such a transition was successfully made or delayed by combining the approaches of economic history and development economics its aim is to identify relevant historical contexts that is the initial conditions and internal and external forces which governed the transition it also aims to understand what current low income developing countries require for their transition three economic driving forces for the transition are identified they are 1 labor intensive industrialization which offers ample employment opportunities for labor force 2 international trade which facilitates efficient international division of labor and 3 agricultural development which improves food security by increasing supply of staple foods the book presents a bold account of each driver for the transition

economic analysis of the industrial experiences of the newly industrialized economies in asia is generally lacking in the literature this study attempts to fill that void by providing an in depth discussion on the economic impact of the industrial policies of singapore taiwan and south korea in the three and a half decades after 1960 throughout the study a broad perspective of macroeconomic development is maintained it is highly critical of the narrow minded objective of certain governments in maximizing the pace of industrialization at the expense of general economic well being a comparative analysis of the industrial experiences of the three economies also shows a diversity of constraints and processes singapore relied on multinational corporations taiwan on returned engineers and south korea on chaebols there appears to be no asian formula for industrialization in hong kong there is an ongoing debate on whether some form of industrial policy should be introduced in view of the perception that hong kong is lagging behind the other economies in terms of technology drawing on the experiences of the other economies the concluding chapter of the book provides an informed and balanced answer to this question

this volume explores japan s industrialization from the perspective of indigenous development focusing on what may be identified as traditional or indigenous factors japanese industrialization has often been described as the process of transferring or importing technology and organization from western countries recent research has however shown that economic development had already begun in pre modern period tokugawa era in japan this economic development not only prepared japan for the transfer from the west but also formed the basis of the particular industrialization process which paralleled transplanted industrialization in modern japan the aim of the volume is to demonstrate this aspect of industrialization through the detailed studies of so called indigenous industries this collection of papers looks at the industries originating in the tokugawa era such as weaving silk reeling and pottery as well as the newly developed small workshops engaged in manufacturing machinery soap brush buttons etc small businesses in the tertiary sector transportation and commerce are also observed available for the first time in english these papers shed new light on the role of indigenous development and our understanding of the dualistic character of japan s economic development
