captures the unique moment in time created by the covid 19 pandemic and uses this as a lens to explore contemporary issues for social work education and practice the 2020 coronavirus pandemic provided an unprecedented moment of global crisis which placed health and social care at the forefront of the national agenda the lockdown social distancing measures and rapid move to online working created multiple challenges and safeguarding concerns for social work education and practice whilst the unparalleled death rate exacerbated pre existing problems with communicating openly about death and bereavement many of these issues were already at the surface of social work practice and education and this book examines how the health crisis has exposed these whilst acting as a potential catalyst for change this book acts as a testament to the historical moment whilst providing a forum for drawing together discussion from contemporary educators practitioners and users of social work services

a growing number of people immigrants refugees asylum seekers displaced individuals and families lead lives that transcend national boundaries often because of economic pressures these individuals continually move through places countries and cultures becoming exposed to unique risk and protective factors though migration itself has existed for centuries the availability of fast and cheap transportation as well as today's sophisticated technologies and electronic communications have allowed transmigrants to develop transnational identities and relationships as well as engage in transnational activities yet despite this new reality social work has yet to establish the parameters of a transnational social work practice in one of the first volumes to address social work practice with this emergent and often marginalized population practitioners and scholars specializing in transnational issues develop a framework for transnational social work practice they begin with the historical and environmental context of transnational practice and explore the psychosocial economic environmental and political factors that affect at risk and vulnerable transnational groups they then detail practical strategies supplemented with case examples for working with transnational populations utilizing this population's existing strengths they conclude with recommendations for incorporating transnational social work into the curriculum

advanced clinical social work practice traces the development of relational ideas from their origin in object relations and self psychology to their evolution in current relational intersubjectivity and attachment theory relational treatment emphasizes openness and collaboration between client and therapist mutual impact the client's subjectivity and the therapist's empathy genuineness and use of the self in therapeutic interaction the approach treats the relationship and dialogue between client and therapist as crucial to the change process and shows how the therapeutic relationship can be used to help clients and therapists bridge differences examine similarities overcome impasses and manage enactments the relational emphasis on the subjective experience of both client and therapist is beautifully illustrated throughout this book as the authors draw from their clinical work with clients from diverse backgrounds including gay and lesbian clients immigrants and clients of color they demonstrate how relational principles and techniques can be applied to multiple problems in social work practice for example life crises and transitions physical and sexual abuse mental disorders drug addiction and the loss of a loved one the authors also discuss the integration of relational constructs in short term treatment and with families and groups this volume opens with a historical perspective on the role of relational thinking in social work and the evolution of relational theory it presents an overview of the key concepts in relational theory and its application throughout the treatment process with diverse clients and in different practice modalities the book concludes with a discussion of the challenges in learning and teaching new theoretical and practice paradigms particularly in creating a more mutual exchange in the classroom and during supervision

this book draws together the learning of a wide range of social workers and other professionals engaged in end of life care who recognise that dying is essentially a social experience and want to tailor a personal professional and societal response accordingly through a systemic lens the book explores the nature and experience of living and dying in the uk today then considers ways in which social workers and others may want to work with people who are affected by a diagnosis of a life threatening condition the contributors offer rich and contemporary perspectives on death dying and loss reflective of their different approaches and interests the insights of the book are timely given the growing levels and changing nature of needs for people who are coming to the end of their life in the uk and beyond and the related requirements for compassionate personalised and holistic care within the increasingly professionalised arena of health and social care this book will be of interest to social work
